ITEM NO. (1) Lynn Brown acted as Chair for the meeting and began with a Roll-Call, welcome and introductions.

ITEM NO. (2) The Chair next formally called the meeting to order at approximately 6:45 p.m.

ITEM NO. (3) The Chair next asked the LAEAC members to introduce themselves and asked for public comments. A member of the public described the Northeast San Fernando Valley Trails project and explained that the National Park Service and the Angeles National Forest have mapped 25 new trails in the vicinity, including Francisquito Canyon, Salt Creek, Fish Canyon, and Red Mountain areas. She noted that the NPS has been asked to erect a memorial recognizing the 1928 failure of the St. Francis Dam and the resulting approximate 600 souls who lost their lives. While the new trails will ban wheeled vehicles, they will be open to equestrians.

Mr. Dave DePinto of the Shadow Hills Property Owners' Association described the trail safety program the association has initiated. He pointed out that both equestrians and motorists must be alert for one another at all times. He presented two trail safety signs the association commissioned.

Lynn Brown reported that the proposed Atwater Bridge project is still moving forward but has been delayed until more private funding can be raised.

Kristen Sabo complained that the fees charged by Dept. of Sanitation for manure containers is too expensive and that this has caused some horse owners to simply allow manure to accumulate, creating what she considers a health risk. She suggested asking the Dept. of Sanitation considering lower the their fees to encourage greater use of the brown manure containers. No action was taken of her request.

- ITEM NO. (4) The Chair next called for a report from the rezoning subcommittee of the Land Use Committee for a report concerning its efforts, the recent Council Motion 14-0389, standards for equine keeping properties and related issues. Jill Haber reported on a recent meeting the Planning Department and her subcommittee. She described an interim proposal by Planning, which, among other things, will require applicants for building permits in K Districts to identify in their applications any equine keeping properties adjacent to the proposed new construction as well as other measures designed to help preserve existing equine uses. This simply an interim proposal until new zoning ordinances are adopted which hopefully will have additional provisions designed to help preserve equine keeping facilities.
- ITEM NO. (5) The meeting chair asked for a discussion of equine licensing and emergency evacuation of equines from fire threatened areas. Mark Salazar, Director of Operations, for LA Animal Services introduced his staff present. He noted that his department currently has 63 field offciers and 12 supervisors. The former DART team has been merged into the department's SMART and has 13 officers assigned to the team.described that capabilities of his department when responding to emergency fire evacuations. Armando Navarette and Hugh Brietman also described the capabilities of the department SMART and that they are working to bring this to the attention of people throughout the city, in particular their techniques and equipment for responding to large animal situations. Vikki Brink also spoke on the subject.

There followed an extensive discussion concerning equine licensing and the need to license more horses. Apparently only 984 horses have current licenses in the city.

- ITEM NO. (6) The Chair next asked Mary Benson to address possible changes to the LAEAC committee structure. Thereafter, following extensive discussion and upon motions duly made and seconded, the following resolutions were adopted:
 - 1. Resolved that Land Use Committee have two co-chairs.
 - 2. Resolved that Documents Committee have two co-chairs.
 - 3. Resolved that RT Committee and the Trails Committee be combined and have two co-chairs.

The following co-chairs were thereupon elected: a. Land Use Committee- Jill Haber and Mary Kaufman; b. Trails Committee- Lynn Brown and Scott Perez; and c. Documents Committee - Dale Gibson and Mary Benson

Mary Benson also reported that the Day of the Horse will be on October 4, 2014. She suggested that it would be appropriate to have an Ad Hoc Day of the Horse Committee to coordinate and plan for the event.

Thereupon a motion was duly made and seconded creating an Ad Hoc Day of the Horse Committee consisting of Scott Perez, Todd Atkins, Julian Sandoval, Nick Pool and Mary Kaufman.

- ITEM NO. (7) The minutes of the March 24, 2014 LAEAC meeting were approved and will be posted on the website
- ITEM NO. (8) The meeting Chair next asked for announcements and suggestions for future meetings. It was reported that the 2015 Special Olympics will be held in Los Angeles athe LA Equestrian Center. This is a major international event and it will be important for the LAEAC to become involved and participate in the planning for this event.
