Program: Parent and child weekends offer families a great opportunity to get better acquainted with one another in a fun and relaxing environment. Children do not have to be related to their adult chaperone. Chaperones must be at least 18 years of age. More than one child can attend but only one parent/chaperone per child. The weekends are open to children 7 to 15 years of age.

Camp Offers: Hiking, arts & crafts, drama, sports, challenge activities, and nature. All programs, meals, lodging, snacks, equipment and security are included in the registration fee.

Applications are accepted and processed on a first-come, first-serve basis. The rules of acceptance and participation in the Camp programs are the same for everyone, without regards to race, color, religion or national origin. Persons with disabilities are welcome to participate in our programs. Reasonable accommodations will be made with prior notification. Please allow a minimum of 2 weeks prior notification for interpretive services.

Registration Process:

No telephone or faxed reservations will be accepted. All camp applications and registration fees are due at least one week prior to the start of the session. If registration is received less than one week, and there is still room in the session, there will be a \$15 late fee charged. It is understood and agreed that no refund or reduction in fees are made for late arrivals, early departures, in's & out's, withdrawal or request to leave due to misconduct. A waiting list will be started after all spaces are filled. Names will be added in the order in which applications are received.

Cancellation & Refund Policy: All cancellations must be made in writing and have a copy of the original receipt. Telephone calls must be followed up with a written request for refund. Refunds take at least 6-8 weeks after the written request is received. Registration fees will be refunded as follows: Less \$10 per person with two weeks or more notice; Less \$25 per person with less than two weeks notice. There are **NO REFUNDS for FAILURE TO SHOW!**

Supervision

Children must be accompanied and supervised at all times by their parent/guardian. Children will not be supervised by the Camp Hollywoodland staff as they are responsible for preparing and leading activities. Adults who leave their children will be called. If the adult refuses to accompany their child, proper authorities will be contacted.
