**Application Procedures:**

This completed application and FULL Payment must be mailed or delivered to the Valley Municipal Sports Office. No faxed applications will be accepted. Application and fees must be received by Friday, Feb. 10 , 2012 at 4:00p.m.

**No refunds will be granted once the league schedules are drawn up- March 9, 2012 !**

Teams will be placed in leagues by past performance. New teams will be placed at the Sports Office's discretion.

Forfeit Bonds are subject to revocation for any of the following reasons:

1. Failure to play games as scheduled.
2. Withdrawal during a League
3. Unsportsmanlike or improper conduct. (Fighting, smoking, alcohol/drug use or possession, use of obscene language)
4. Failure of any player to abide by an umpire's decision.
5. Failure to be active for a three (3) consecutive year period.

Note: Suspension or revocation of Forfeit Bond may result from any of the above. Forfeit Bonds will revert to the Municipal Sports Account to be used in further promotion of Sports Activities.
