

RECOMMENDATION:

That, inasmuch as Westway Construction has reinstated its license, the request for substitution of subcontractor be denied.

SUMMARY:

The Department is in receipt of a request from Iraj Khorrami, dba Shefir Construction Company, general contractor for the MacArthur Park - Facility Improvement (#1841A), Contract No. 3009, to substitute Conex Roofing for Westway Construction for the roofing subcontract work on this project. The request was made inasmuch as Westway Construction license was suspended.

Pursuant to Section 10.14 of the Los Angeles Administrative Code, Westway Construction was notified of the substitution request and has filed an objection, stating that their license was temporarily suspended for filing the wrong certificate Workers Compensation insurance with the Contractor's State License Board. At the time of renewal, their insurance agent filed the name of the carrier improperly which resulted in suspension of their license (see attached letters). However, their license is now reinstated.

Inasmuch as Westway Construction's license is now reinstated, there is not valid basis for the requested substitution at this time.
