The L.A. For Kids Steering Committee has reviewed the bids and recommended that the Recreation and Parks Board award a construction contract.

The City Attorney has reviewed the bids and found them to be in order. A.B.C. Lawn Sprinkler Co. Inc. was the lowest responsible bidder.

Staff has reviewed the outreach effort made by A.B.C. lawn Sprinkler Co. Inc. and, based on the documents submitted, has determined that a "good faith" effort has been made. The contractor obtained an MBE/WBE participation of (7%) and satisfied (81) of the (100) point requirements outlined by the Board's Outreach Program. The Outreach Document package is on file in the Board Office and synopsis of said package is attached.

Staff reviewed the responsiveness and work performance of A.B.C. Lawn Sprinkler Co. Inc. on past Department projects and found them to be satisfactory. The Department of Public Works, Office of Contract Compliance (OCC), indicated that there have been no labor compliance violations and that all other legal requirements have been complied with.
