What We Do At Camp

Check In: Friday 5:00 PM - 6:00 PM. Campers who show up after 6:30 PM will not be accepted into the program.

Check Out: Sunday 12:00 PM - 1:00 PM.

Daily Program: The program is scheduled from 7 AM (rise & shine) until 8:30-9:30 PM (lights out). During the course of the day, campers choose activities by cabin groups, age groups and individually. All activities are taught by trained, experienced staff.

Applications are accepted and processed on a first-come, first served basis. The rules of acceptance and participation in the Camp programs are the same for everyone, without regards to race, color, religion or national origin. Persons with disabilities are welcome to participate in our programs. Reasonable accommodations will be made with prior notification. Please allow a minimum of 2 week prior notification for interpretive services.

Make checks out to: CITY OF LOS ANGELES. All camp applications and registration fees are due at least one week prior to the start of the session. If registration is received less than one week, and there is still room in the session, there will be a \$20 late fee charged. It is understood and agreed that no refund or reduction in fees are made for late arrivals, early departures, in's & out's, withdrawal or request to leave due to misconduct. A waiting list will be started after all spaces are filled. Names will be added in the order in which applications are received.

Cancellation & Refund Policy: All cancellations must be made in writing and have a copy of the original receipt. Telephone calls must be followed up with a written request of cancellation for a refund. Refunds take at least 6-8 Weeks after the written request is received. The registration fee will be refunded as follows: Less \$10 with two weeks or more notice ; Less a \$25 with two weeks or less notice - processing fee (per child/per Getaway). There are **NO REFUNDS for FAILURE TO SHOW!** We reserve the right to cancel any program at least one week prior, due to low registration, with a full refund.

In consideration of the City of Los Angeles acting through its Department of Recreation and Parks at Hollywoodland Girls Camp ("Camp") granting the above-named child ("Minor") the opportunity to participate in the Camp Hollywoodland Camping Girl Getaway Program ("Program") I, (print name) _____ the undersigned, as the parent/guardian of (print name) _____ ("the Minor"), do hereby agree as follows:

I am aware that there are certain risks of injury and/or damage inherent in the Program's activities;
I understand that if my child misbehaves and/or is sick and needs to be sent home;
I agree to pick them up at the time requested by the Camp staff;
I agree to complete the Camps' Health History form providing Minor's current, complete and truthful health history; including immunization history and overall health status;
I understand that under certain medical conditions the Camp staff may require a written authorization based on a physical examination by a licensed medical persons as requirement for the Minor to participate in the Program;
I confirm to the best of my knowledge and belief the Minor is not subject to a physical or mental infirmity nor under the influence of any medication or substances which might hinder their safe participation or the safety of others in the Program;
I will instruct the Minor to abide by all safety rules, policies and regulations and to take reasonable precautions to minimize risks of injury or damage arising from participation in the Program;
I give my consent to have the Minor participate in all aspects of the Program;
I knowingly assume full responsibility for all risks of bodily injury, emotional injury, death or property damage that may occur in relation to the Minor as a consequence of participation in the Program at the Camp;
I give my consent to have the Minor transported by: car, van, chartered bus, chartered school bus and/or public transportation as part of the Program;
I understand that the Camp has no obligation to obtain medical treatment for the Minor. Should it become necessary for the Minor to have emergency medical care while participating in the Program;
I hereby give the Camp personnel my permission to use their judgment in obtaining medical care, and;
I give permission to the medical care provider selected by the Camp personnel to render medical care deemed necessary and appropriate;
I understand that the Camp at it's sole option but without obligation may procure insurance to cover part or all of such medical expense incurred by the Minor;
I understand and agree that any cost incurred for such treatment which is not covered by insurance shall be my sole responsibility;
Except for the gross negligence or willful misconduct of the Camp, I (print name) _____ waive all rights of recovery which the Minor or I may have now or in the future, whether known or unknown, against the City of Los Angeles, Department of Recreation and Parks, Hollywoodland Girls Camp its officers, agents, employees and/or personnel, and
I release, acquit and forever discharge the City of Los Angeles, Department of Recreation and Parks, Hollywoodland Girls Camp its officers, agents, employees and/or personnel, from and all liability for any bodily injury, emotional injury, or other personal injury, damage, loss or expense, claims, demands, causes of action, costs, loss of services or use, compensations, debts, monetary damages, including but not limited to attorney fees, which result from or are in any way connected with the Minor's participation in the Program or any related activities;
I agree to keep the Camp advised if I will be out of contact for any period of time during the Program and to provide additional and/or alternate contact information prior to my leaving;
I also authorize the Camp/City of Los Angeles and Department of Recreation and Parks to make, procure and/or use photographs, films, tapes, digital media recordings or other likeness of the Minor's physical image and/or voice as for use with the Program and/or Camps' publicity, marketing and/or advertising materials;
I have read this agreement and I understand what it means to my legal rights and the Minors participation and by my signature made of my own free will and act;
I agree to abide by the rules and policies set forth in this registration and waiver release form;
I have read and understand the payment, refund and conditions of enrollment policies as found in this registration form;
I agree to be legally bound by signing this registration form and extend this binding to the Minor.
