AUTHORIZATION TO PARTICIPATE My child, a minor, has my permission to participate in the Balboa Sports Center Sports Camp program and all activities therein, including chartered vehicles for trips. By my child's participation in the camp program I understand that certain activities by nature have an increased risk of injury, including death, despite extensive measures taken by the camp staff to provide a safe environment and ensure the safety of my child. I understand the nature of the camps games and sports activities and am aware of the minor's experience and capabilities and believe my child to be qualified, in good health, and in proper physical and emotional condition to participate in such activities. I agree to relieve the City of Los Angeles Department of Recreation & Parks, its officers and agents and employees from any injury to my child in connection with this program. I further understand that the City of Los Angeles Department of Recreation & Parks and Balboa Sports Center CARRIES NO INSURANCE. I further agree that the City of Los Angeles Department of Recreation & Parks and Balboa Sports Center has my permission to use photographs, video and/or auditory statements taken during camp activities for publicity purposes.

CONSENT TO TREATMENT OF A MINOR I, as the parent and/or legal guardian of the minor participating in this program, do hereby authorize the City of Los Angeles Department of Recreation & Parks to act as agents for the undersigned to consent for any x-ray examination, anesthetic, medical or surgical diagnosis or treatment and hospital care which is deemed advisable by, and is to be rendered under the general or specialized supervision of any physician licensed under the provisions of the Medicine Practice Act on the staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician or a said hospital. It is understood that this authorization is given in advance of any such diagnosis, treatment or hospital care which the aforementioned physician in the exercise of their best judgment may deem advisable. This authorization shall remain effective through the conclusion of the event or program that the minor is participating in, unless revoked sooner in writing and delivered to said agent.

GENERAL CAMP POLICIES **Important Notice:** Due to the nature and size of the Balboa Sports Camps, the age of the campers, and to provide a safe and enjoyable camp environment for each participant, Balboa Sports Center and the Balboa Sports Camps demands a high level of maturity and responsibility from each camper as a prerequisite to attend our camp. While we understand that campers are still children, we hold each individual accountable and responsible for their actions and behaviors at all times. Individuals who repeatedly violate camp rules, cause excessive distraction in camp, require disproportionate camp staff attention, supervision, and/or discipline, or show continued disrespect towards camp staff or other campers will not be tolerated, and those individuals will be expelled from camp.

1. Campers must be age appropriate by the last day of camp and may be required to show proof of age.
2. **CAMPERS MUST WEAR THEIR CAMP SHIRT OR CAMP BADGE DAILY. CAMPERS 11 TO 14 IN A GROUP OF FOUR – SIX MUST BRING A WATCH ON EVERY FIELD TRIP THEY ATTEND. THIS IS FOR SAFETY, IDENTIFICATION AND TEACHING RESPONSIBILITY AND AWARENESS OF MEETING TIMES. CAMPERS NOT WEARING A CAMP SHIRT OR CAMP BADGE WILL BE CHARGED \$10.00 FOR A NEW ONE.**
3. Campers are responsible for their own actions and behavior at all times. The following actions may be cause for immediate suspension or expulsion from the Balboa Sports Camp program: using, providing, or being under the influence of any drugs or alcohol; theft; profanity and or abusive language; fighting; vandalism; unwanted or inappropriate sexual contact and/or harassment; campers arriving late to a meeting location; campers separated from their group; and/or any other actions that the Camp Staff deems inappropriate. Participants caught shoplifting on a trip will be left with on-site security and it will then be the parents' responsibility to pick-up their child.
4. All campers will be directly or indirectly supervised on all field trips within designated boundaries. Campers may be with a counselor led group (campers age 5 – 11), with a buddy (ex: at an arcade), or in a group of 4 – 6 (only campers age 11 – 14), depending on the trip site, activity, age, responsibility and parent authorization of each camper.
5. **SUSPENSIONS & EXPULSIONS**
 - A. Campers who are suspended or expelled from camp will receive no refund or prorated fees for the day or the remainder of the week that they were suspended from. Any fees paid towards future week registration will be refunded according to the Refund Policy minus any fees owed.
 - B. **SUSPENSIONS:** Campers suspended on their last registered day of a week will not be allowed to return to camp until the number of suspended days has been fulfilled from their next week of registration. Days missed while serving a suspension are not eligible for a refund.
 - C. **EXPULSIONS:** Campers expelled will not be permitted to attend camp for the remainder of the current camp season.
6. Policies regarding Registration, Payment Dates and Fees, Camp Hours, Sign-In & Sign-Out, Extended Care, Discounts, Refunds, Changes, Adding Days, Camp Shirts, Camp Badges, Watches on trips, Clothing, Equipment from Home, Lunches, Snacks, Field Trips and policies not listed here will be handled according to the policy as listed in the camp brochure.
7. No Make-ups, substitutions or pro-ration of days will be permitted.
8. Camp Staff reserves the right to alter or change programming at any time without prior notice.
9. Registration is on a first come, first serve basis as there are limited spaces available. Subsequently, Balboa Sports Center is not responsible for mailed registration that is either lost or delayed.
