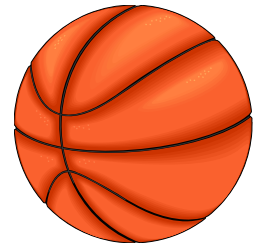

League Notes:

- Legal uniforms are required by the 2nd game to avoid penalties for players not in legal uniform. Uniforms must have permanent numbers on the front and back, and meet Muni rule specifications (see Rules for Governing Play).
- ALL ROSTERS, WAIVERS, CODE OF CONDUCT, AND ADD/DROP FORMS MAY ONLY BE SUBMITTED TO THE VALLEY SPORTS OFFICE. Scorekeepers have been instructed NOT to accept any paperwork from teams and/or managers
- Original Team Roster is due in the Sports office before the date of the 3rd league game. Only Original Complete Roster Accepted. (Receipt date effects City-wide Tournament invitation and protests)
- The last day to submit an Add/Drop form is prior to the first game of the second round. NOTE: Players MUST participate in a minimum of 5 league games to be eligible for the Play-offs and/or City-Wide Tournaments.
