This form must be completed entirely and accurately by all players who are being added or dropped to the Team Roster. If the player/s that is being dropped is to be activated with another team, the player/s must submit to the soccer office a player/s dropped form from his/her current team, before a new add form can be accepted from the team he/she is being added to. The players ID must also be turn in to the soccer office. Failure to comply with any of this protocol shall result in forfeiture of the game(s).
