Surrounding Land Uses and Setting (briefly describe the project's surroundings):	MacArthur Park is bounded by West 6th Street on the north, South Alvarado Street on the east, West 7th Street on the south, and South Park View Street on the west. Wilshire Boulevard passes through the center of the park in an east-west direction. Uses immediately surrounding the park include general commercial, government services, an elementary school, multi-family residential apartment buildings, and a multi-story hotel.
