



Exposition Park Rose Garden

The Rose Garden is run and operated by the City of Los Angeles Department of Recreation and Parks.

This seven acre site evolved from what was known as the "Sunken Garden" during the early twentieth century. When it was officially unveiled to the public in the year 1928 the garden proudly displayed 15,793 rose bushes. Today the garden boasts over 145 different varieties of plants and 10,000 roses whose strong aromatic scent is enjoyed every day by visitors to the garden.

The Rose Garden is visited by hundreds of thousands of Angelinos and tourists from around the world each and every year. Used as an urban oasis by the local residents in the community, the garden stands as a place for quiet reflection, meditation and refuge from the daily grind.

On most weekends, between the months of April and November, the Rose Garden is a choice location for weddings, picnics, family outings and other memorable excursions. The Rose Garden is open daily from 8:30 am to sunset. It is closed to the public from January 1 to March 15 of each year for routine maintenance



RENTAL INFORMATION

Weddings / Pictures / Special Events

Reservations must be made at least six (6) weeks prior to the date of your event. The following information will help you in planning your ceremony at the Exposition Rose Garden.

RESERVATIONS and FEES

Ceremonies may take place between 9:00am – 4:00pm. There is a 2-hour maximum time limit for each ceremony. The maximum number of guests is 200.

Refundable clean-up fee	\$500.00

Application Fee	\$35.00

Note: Event Setup and break down requires a minimum of two hours per event, as well as a two staff minimum for setup. Additional Staff may be required as determined by the Event Coordinator. A price increase may occur due to salary increases from the City.

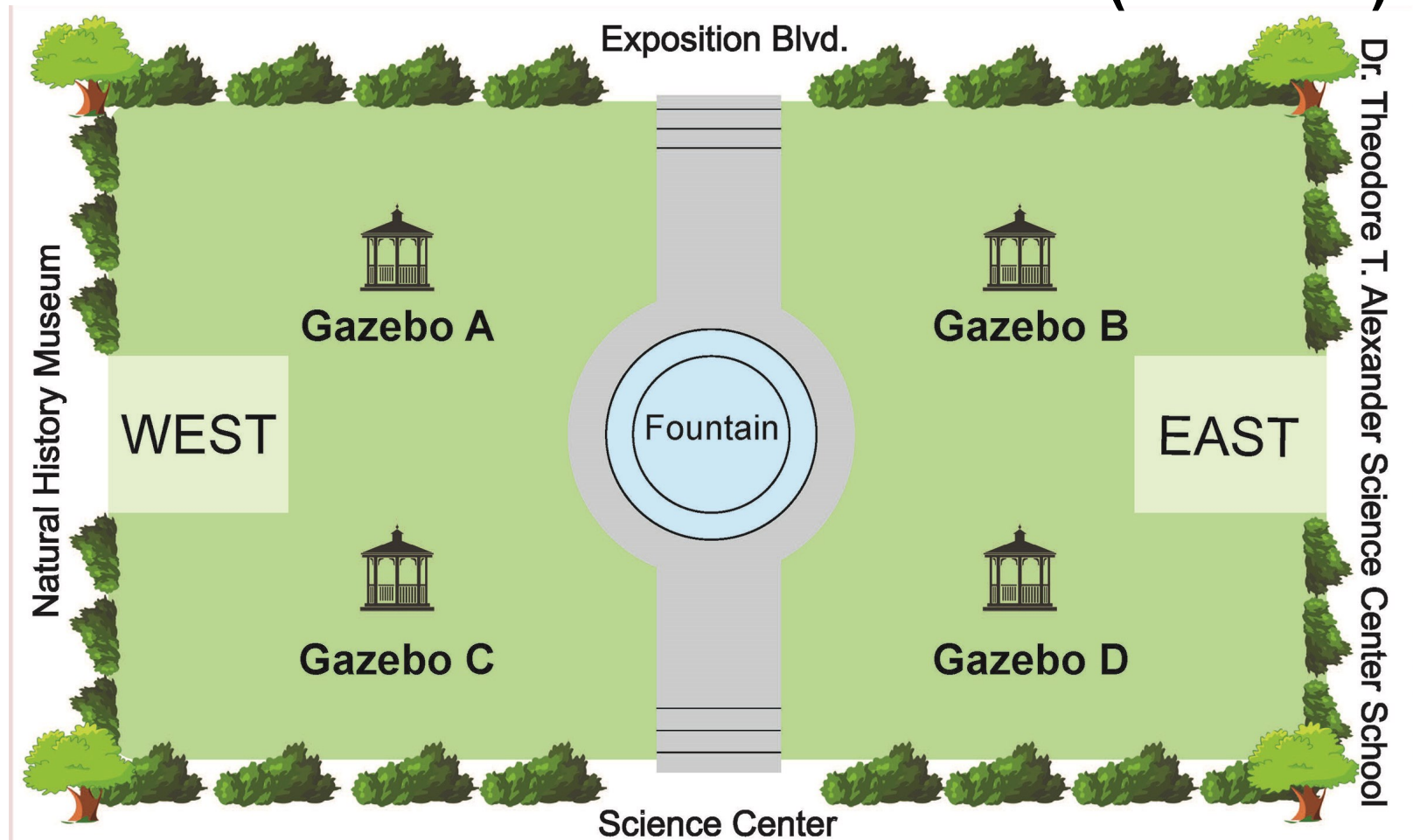
