The Historical Exposition Park Rose Garden is a favored venue for special celebrations including weddings, quinceañeras, award ceremonies, and is also a popular location for yoga classes, dance lessons and performances, picnics, family outings and outdoor excursions. Voted as the "most beautiful garden" in Los Angeles by Sunset *Magazine*, and listed as "one of the most pleasant places in Los Angeles," by LA Weekly, the garden is visited by more than a million people every year.

The garden is a seven acre site that evolved from what was known as the "Sunken Garden" during the early 20th century and was officially unveiled to the public in 1928 with over 15,000 rose bushes. It is the second largest garden of its kind in California and is listed on the National Register of Historic Places. Today, the garden boasts over 200 different varieties of plants and flowers whose aromatic scents are enjoyed by its visitors.

Operated by the City of Los Angeles Department of Recreation and Parks, the Rose Garden is open daily from 9:00 a.m. to sunset and is closed to the public from January 1 to March 15 each year for pruning. 
