RECOMMENDATIONS

- 1. Accept the work performed to construct the Hansen Dam Phase III Road and Trail Improvements project (W.O. #E170422F) (Project), completed by the Department of General Services (GSD), as outlined in the Summary of this Report;
- 2. Authorize the Board of Recreation and Park Commissioners (Board) Secretary to furnish GSD with a Letter of Completion; and,
- 3. Authorize Department of Recreation and Parks (RAP) Chief Accounting Employee or Designee to make technical corrections as needed to fulfill the intent of this Report.

SUMMARY

The Project is located at 12200 West Osborne Street, Lake View Terrace, California 91040, on land owned by the U.S. Army Corps of Engineers (USACE). The USACE agreed to lease the property to the City of Los Angeles for recreational development.

The Proposition K – L.A. for Kids Program (Proposition K) Ballot measure specified the scope of work for Hansen Dam to include a Soccer Complex (Phase I), Ranger Station (Phase II), Road and Trail improvements (Phase III), and a Recreational Vehicle Park (Phase IV). To date, Phases I, II, and III have been completed.

The Phase I project scope included the design and construction of regulation size soccer fields, parking lots, picnic areas, water fountains, a softball facility, a concession building, a public restroom, and site fencing. The Phase I project was approved by the Board in Board Report No. 03-203 (Attachment No. 1).

The Phase II project scope included the design and construction of a new single story 4,600 sf Ranger Station building that includes park ranger offices, public restrooms, a visitor center, a communication center, a lunchroom, and storage. The Phase II project was accepted by the Board in Board Report No. 14-269 (Attachment No. 2).

The Phase III Project scope included the installation of three Trail Entry Map Signs, eight Road and Trail Pedestrian Directional Signs, and eighteen Half-Mile Markers on three loops. The Trail Entry Map Signs showing the major trails within the Hansen Dam Recreational Area are located at the Ranger Station and start of the trail system. The Road and Trail pedestrian directional signs are located at major road and trail intersections. The eighteen Half-Mile Markers are located along three major trail loops. "Loop One" is a five-mile loop located on the west side of Hansen Dam with nine Half-Mile Markers. "Loop Two" is a four-mile loop located on the east side of Hansen Dam with seven Half-Mile Markers. "Loop Three" is a one-mile loop with two Half-Mile Markers located at the south side of Hansen Dam.

The Project construction was awarded to GSD through a Memorandum of Understanding with a Not to Exceed Amount of \$1,040,000 that was last approved by the Proposition K Steering Committee in a Proposition K Steering Committee Report dated June 25, 2015 (Attachment No 3). Signage fabrication began on April 1, 2021 and installation was completed on September 30, 2021.

Plans and specifications for the signs were prepared by Frank R. Webb Architects, Inc. in collaboration with the Mayor's Office, Council District 7, RAP, Bureau of Engineering (BOE), and the USACE. BOE performed project management and construction management services for the Project.

As required for all Proposition K projects, the design was presented and approved during the course of three Local Volunteer Neighborhood Oversight Committee meetings.

The breakdown of the total construction cost is as follows:

The Project's construction had a total of one executed change order for a total amount of \$31,154.00, or 42.42% of the base contract amount, which increased the total construction contract to an amount not to exceed \$104,592.00. The single change order issued in the amount of \$31,154.00 addressed additional signage for the USACE after GSD provided their estimate for the Project.

SUMMARY:

The construction contract for the Hansen Dam - Soccer Complex, (#1347A) project was awarded to Saddick Construction Co., Inc., on June 5, 2002 in the amount of \$473,000.00. Construction began on July 10, 2002 and was complete on May 13, 2003. The project scope provided for the construction of new soccer fields in the Hansen Dam Recreation Area.

The Bureau of Engineering Construction Management Group provided contract administration of the project for the Department under the Prop K program. The Program Manager advised the Department in writing on May 19, 2003, that the project was complete and the contractor had furnished all required permits, drawings, Maintenance and Operation Manuals, and Guarantees.

The Prop K Program Manager has informed the Department that the Construction Management Group completed this project with seven (7) change orders in the amount of \$46,839.72.

RECOMMENDATIONS:

That the Board:

- 1. Approve the final acceptance of the work performed to construct the Hansen Dam -Phase II - Ranger Station (W.O. #E170405F) project, under the Memorandum of Understanding (MOU), between the Department of Recreation and Parks (RAP), Department of Public Works, Bureau of Engineering (BOE), and the Department of General Services (GSD), Construction Forces as outlined in the Summary of this Report;
- 2. Authorize the Board Secretary to furnish GSD with a letter of completion for the subject project.

SUMMARY:

On June 17, 2009, the Hansen Dam – Phase II – Ranger Station (W.O. #E170405F) project was awarded to the GSD in the amount of \$4,650,000.00 (Board Report No. 09-169), through the approval of a Memorandum of Understanding (MOU) between RAP, GSD and BOE for the construction of a new Ranger Station. Funds were obligated prior to the end of Fiscal Year 2008-2009 by way of an executed MOU in order to avoid loss of the Proposition K funds.

The Hansen Dam – Phase II – Ranger Station (W.O. #E170405F) project, located at 12200 West Osborne Street, Lake View Terrace, California 91342, called for the construction of a new, single story, 4,600 square foot building. The building includes offices for the park rangers, a visitor center, including the entry point for the patrons of Hansen Dam campgrounds and equestrian trails, public restrooms, a community meeting room, a communication center,

lunch room and storage. The project also has park ranger and visitor parking, road improvements including reconfiguration of the park entrance to monitor site access, site grading and landscaping, and new utility connections including an extension of the sewer line. The building roof line extends beyond the building envelope providing a shade structure covering most of the front lawn to allow for outdoor events to be held comfortably.

The original MOU amount of \$4,650,000.00 was a budgetary figure provided to GSD and was not based upon a cost estimate developed by GSD. It was recognized at the time of award to GSD that the MOU would have to be amended to reflect the total construction cost, at the time of completion of plans and specifications for the project.

Upon completion of the plans and preparation of a detailed construction cost estimate, GSD requested an additional \$1,892,531.00 to fund the construction of the project. A Supplemental Agreement to the MOU (SMOU) was approved by the Board on February 18, 2011 (Board Report No. 11-053), and the funds were transferred to GSD. The MOU amount, including a 10% contingency of \$594,776.00, had a new total not-to-exceed amount of \$6,542,531.00.

Due to the complex design of the project, numerous unforeseen conditions, errors and omissions in design as well as in GSD's original construction cost estimate, additional funding was requested by GSD, in an amount of \$907,469.00, for a new total not-to-exceed amount of \$7,450,000.00. The additional funding was approved by the L.A for Kids Steering Committee on May 30, 2013 and an Amendment to the SMOU was approved by the Board on November 6, 2013 (Board Report No. 13-275).

GSD completed the project on November 30, 2013, and the quality of the work is excellent. A total of seventy-five (75) Change Orders were approved, for a total amount of \$797,832.83, or 12% percent of the total final construction cost. The Change Orders were like result of errors and omissions in the construction documents, as well as unforeseen conditions, and added and/or changed scope to improve serviceability and functionality and scope not captured in GSD's original construction cost estimate. The final total construction cost, including change orders, was \$7,442,560.91. There are no contract compliance or labor issues with the work done under this MOU.

FISCAL IMPACT STATEMENT:

At this time, there is no fiscal impact to RAP's General Fund, due to \$14,050.00 requested and received in the City's Fiscal Year 2012-2013 budget for part time maintenance staff funding. However, future operational maintenance costs will be determined and a request for funding will be submitted in future Department's annual budget requests.

DISCUSSION/BACKGROUND

The proposed Hansen Dam Phase III – Road and Trail Improvements project (R-16, CD 7 Regional Specified) is a Proposition K – L.A. for Kids Program Specified project, located at 12200 West Osborne Street, Lake View Terrace, California 91040. The project site is located in the San Fernando Valley, within the Hansen Dam Flood Control Basin and Recreation Area, on land owned by the U.S Army Corps of Engineers (USACE), and leased to the City of Los Angeles for recreational development. The Proposition K line item scope of work includes "soccer complex, recreational vehicle (RV) park, ranger station/visitor's center, road/trail improvements, and fencing."

The overall Hansen Dam project was proposed to be constructed in phases. Phase I completed the soccer complex, Phase II the ranger station/visitors center and both Phases I and II included fencing. Phases I and II are complete.. The proposed Phase III project will provide road and trail improvements. A future Phase IV project will construct the RV park.

Initially, the road and trail improvements were broken out into two projects known as the Hansen Dam Phase IIIA – Road Improvements and Hansen Dam Phase IIIB – Trail Improvements. The Hansen Dam Phase IIIA – Road Improvements (W.O #E170405F) project was awarded to GSD on May 16, 2012 (Board Report No. 12-145) for an amount of \$640,000, which included \$65,000 in contingency. In order to avoid a loss of funds, monies were obligated prior to the end of Fiscal Year 2011-12 by way of an MOU, executed on June 20, 2012 for a two year term. The MOU has expired and no monies were ever transferred to GSD. Now, Hansen Dam Phase IIIA – Road Improvements project and Hansen Dam Phase IIIB – Trail Improvements project will be combined together and referred to as one new project entitled Hansen Dam Phase III – Road and Trail Improvements ("Phase III Project"). The Phase III Project will be awarded under a new MOU.

Staff recommends awarding the Phase III Project to GSD, in lieu of conducting a competitive construction bid process, because the Phase III Project proposes to improve road and trails adjacent to the new Hansen Dam Ranger Station, which was constructed by GSD. Moreover, GSD is familiar with the site, GSD is knowledgeable about the Phase III Project, GSD has already constructed prior phases of the overall Hansen Dam project, GSD is qualified to do the work and GSD is available to do the work. Also, awarding to GSD in a timely manner will allow the construction schedule for the Phase III Project to be met. Therefore, it is

recommended that GSD be selected to construct the Phase III Project, in accordance with Section 22.535(a)(5) of the Los Angeles Administrative Code.

The \$1,040,000 amount of funding in the MOU for the Phase III Project is a budgetary figure and is not based upon a cost estimate developed by GSD and may not reflect the total construction cost. Upon receipt of the GSD cost estimate, BOE may reduce the scope of work and/or request authorization to increase the construction budget in order for GSD to complete the Phase III Project. It is also recommended that the MOU term be for thirty six (36) months.
