REGULAR MEETING MINUTES

BOARD OF RECREATION AND PARKS COMMISSIONERS OF THE CITY OF LOS ANGELES

Thursday, July 18, 2024

The Board of Recreation and Park Commissioners of the City of Los Angeles convened the Regular Meeting at 9:00 a.m. Present were, President Renata Simril, Commissioner Fiona Hutton and Commissioner Benny Tran. CALL TO ORDER

APPROVAL OF THE MINUTES

President Simril called for a motion to approve the minutes of the Regular Meeting of June 20, 2024. Commissioner Tran made such motion, and it was seconded by Commissioner Hutton. There being no objections, the motion was unanimously approved by a vote of 3-0.

GENERAL MANAGER'S UPDATE

Jimmy Kim, General Manager, began his update by thanking Anita Meacham and all the staff who assisted for doing an amazing job with lotus festival this past weekend.

Mr. Kim provided a few updates from various communications received by constituents. Mr. Kim provided some background on El Sereno Recreation Center programming that was mentioned at our last meeting. He stated El Sereno has two centers a Recreation Center and a Senior Center. Mr. Kim stated the Senior center operates Monday through Friday from 8 a.m. to 5 p.m. The Yoga class that was mentioned during public comment was, in fact, a program held at the senior center, but was held there due to space limitations at the recreation Center, and so that class, unfortunately, was cancelled because the instructor for that class was unavailable. Mr. Kim mentioned that the senior center does still offer chair Yoga, on Tuesdays and Thursdays from 9:30 a.m. to 10:30 a.m., and we expect the other programming to start up again once we identify an instructor that could go ahead and take on that class.

Mr. Kim provided a brief update on golf. As it relates to the Department's golf course operations. He stated he's happy to report that the \$10 non-refundable deposit pilot program has significantly reduced tea time cancellations. It has also mitigated brokering activities and has overall made it easier for golfers to book tea times. Mr. Kim mentioned he has gotten a lot of compliments from some of the golfers who have been successful at booking tea times.

Next, I wanted to bring up the Elysian Park social media posts regarding the children's area. By way of background, the department received concerns by members of the public regarding the impacts of a brush clearance that we performed in Elysian Park, specifically related to the areas adjacent to the Gracie Simons Lodge Building. The Department annually works with the pregualified landscape maintenance contracts to perform brush clearance as required by the fire department. Which is increasingly important due to extreme fire heat conditions, so based on our initial assessment, our department's forestry division identified that the brush clearance did not result in a removal of protected native trees. However, the brush clearance did unintentionally impact an outdoor learning environment seasonally used by a permitted nature-based education group, and it also impacted some of the trees and native plants habitat that was planted in that area. Some of the nearby signages that they put up was also affected. RAP is further assessing the brush clearance work performed by the contractor, particularly as it relates to the concerns regarding the damage of native trees, and the department is engaging with the community stakeholders to address these impacts and will be reviewing our brush clearance protocols to make sure that the areas that are slated for brush clearance are identified, and that they understand what protocols need to be followed on an annual basis.
