.Mr. Kim provided the Commission an update regarding summer camp registration he stated we had a small hiccup with our registration system because we would normally have 30,000 visitors to visit the website but on the registration opening day, we had over 200,000 visitors to access the website. He also stated we have a few capacity issues in which the department is currently recruiting and hiring new employees so that we can increase the capacities at summer camps.
