#### Thursday, October 17, 2024

The Board of Recreation and Park Commissioners of the City of Los Angeles convened the Regular Meeting at 9:00 a.m. Present were, Vice President Luis Sanchez, Commissioner Fiona Hutton and Commissioner Marie Lloyd. ## **CALL TO ORDER**

## **APPROVAL OF THE MINUTES**

Vice President Sanchez called for a motion to approve the minutes of the Regular Meeting of October 3, 2024. Commissioner Hutton made such motion, and it was seconded by Commissioner Lloyd. There being no objections, the motion was unanimously approved by a vote of 3-0.

## **GENERAL MANAGER'S UPDATE**

Matthew Rudnick, Executive Officer, began his update by stating he was filling in for Jimmy Kim, General Manager while he is representing the Department at a summit convened by the Mayor's office with a delegation from Paris. The delegates from Paris are in town to discuss lessons learned from the 2024 Olympic and Paralympic games. As the city prepares for the 2028 games. The Summit is being hosted at our RAP EXPO center.

Mr. Rudnick introduced Kimberly Simonet Principal Recreation Supervisor II over the Metro Region to introduce staff and provide a little background of our Metro Region and the Glassell Park Recreation Center. Mr. Rudnick share a few updates, he stated RAP is gearing up for their Halloween and Fall festival events at many of our Recreation Centers.

Mr. Rudnick mentioned the Mayor released a new Executive Directive 9, that's titled Repairing streets, cleaning parks, and enhancing infrastructure and city services ahead of major upcoming events. in LA. Those events are the World Cup in 2026, and the Olympics in 2028. So, the department is engaged in a variety of ways to support that undertaking, and we'll be reporting back to the Board on the department's participation.

Mr. Rudnick provided an update on the Rancho Park Golf course clubhouse and restaurant. This was a request by the community and by the board to come back with a bit more information. So, the Department has notified the tavern at Rancho Park our concessionaire that they have until October 31st at the end of the month, to secure financing, to resume the renovation project.

Patrick Siggins from Council District 4 provided a brief update on the Ambassador program for the ABH Riverside location which he believes will begin on November 1<sup>st</sup>.
