#### **Announcement for Rancho Community**

Dear Burbank, Glendale, and Los Angeles Equestrian Center Communities -

During this extremely challenging time of fires and loss across Los Angeles, I wanted to reach out to acknowledge the incredible tragedy our neighbors have faced and to thank the heroic first responders who have been working tirelessly to protect us. The remarkable outpouring of kindness and support from so many volunteers has been truly inspiring. Los Angeles, a county of nearly 10 million people, has felt like a small town over the past week.

We also want to share some wonderful news for the entire Equestrian community. River LA has purchased the land at 914 S Mariposa Street in Burbank - including a section of the Los Angeles River. We want to share details about this purchase, and our intentions for the property.

First and foremost, River LA partnered with the Mountains Recreation and Conservation Authority (MRCA), a local public agency dedicated to the acquisition, preservation, and protection of open space, to ensure that the land never be developed. This unique access point for horses and their riders, along with the general public, will have River LA & MRCA as its stewards, providing access to the open space in Griffith Park.

Second, we are thrilled that Dario Perez and his team – Javier Ochoa and Adrian Ramirez – will continue to run the Studio Horse Rentals and be our partners. Together, we will explore additional community benefits for the land, horses, and public that we might add to the property. We will continually keep you informed. Finally, I want to express our deepest appreciation to a remarkable group of women who have shown such love and commitment to this community. 





Below is a copy of my public comments made at the RAP Commission Commisson Board meeting February 6, 2025.

I asked General Manager Kim and Assistant General Manager Aguirre and the RAP Board to:

- 1) Invite back the CAO and Council District 4 Councilmember Raman to answer questions regarding the CAO report as the Board and public only received the CAO briefing the day after the requested report. As well. Councilwoman Raman can clarify her Ambassador Program. (Be aware of the fact that what Councilwoman Raman defined as the Ambassador Program to the community 1.5 years ago and CD4 Homelessness Deputy Pat Siggins' comments on December 19, 2025 were diametrically opposed. Thus there is no clarity about the true nature/scope/intent/outcome/metrics for success of the role of the Ambassador Program. There needs to be a better definition as well as metrics need to be established for accountability and transparency for both shelter residents and the broader community).
- 2) Understand that RAP and Griffith Park is not protected with the current interdepartmental agreement the City Attorney thinking an interdepartmental agreement is a tightened document along the lines of an Memo of Understanding (MOU) is incorrect, and RAP should not renew the license/ROE permit for Riverside Bridge Home shelter until such an MOU exists and CD4 submits to a written report clearly defining the Ambassador Program. Frankly, CD4 needs to be encouraged to communicate truthfully with the RAP Board of Commissioners, GM Kim and ASM Aguirre, as well as the broader community.
- 3) Know that shelter residents are in the process of filing further grievances for greater transparency and accountability in the Bridge Home program. If and when I receive a copy of that alleged complaint, I will let you know and furnishs alleged complaint. These folks are guests in a temporary facility and their health and safety matters to me.
- 4) Please agendize the Griffith Park Adult Community Center (GPACC) to discuss the center as it was promised to be renovated and moved across the street by Councilwoman Raman on 2/29/25. GPACC leadership attended the

June 2025 RAP Commission meeting and other meetings, and so far, they deserve an update about progress relayive to the the Community Center and the south Griffith Park Master Plan. As I understand it currently, there has been no movement on the RFP. It would be greatly appreciated if Councilwoman Raman and Darryl Ford can update the community.

I thank you for all your work on the Commission and hearing from the public on the above matters. Your leadership and that of General Manager Kim and Assistant General Manager Aguirre and GM Kim have been tremedous, particularly in light of these challenging times and recent fires in our parks and communities.

Understand that RAP and Griffith Park is not protected with the current interdepartmental agreement the City Attorney thinking an interdepartmental agreement is a tightened document along the lines of an Memo of Understanding (MOU) is incorrect, and RAP should not renew the license/ROE permit for Riverside Bridge Home shelter until such an MOU exists and CD4 submits to a written report clearly defining the Ambassador Program. Frankly, CD4 needs to be encouraged to communicate truthfully with the RAP Board of Commissioners, GM Kim and ASM Aguirre, as well as the broader community.

Today we are taking the time to report graffiti on this bench one more time.

Picture #1- 11/26/24 a city worker came to cover graffiti around the kid's playground and restrooms. Some graffiti was covered except for writing on the side of this bench. We brought it to his attention but he refused to do it. We reported it to his supervisor who did nothing about it.

Picture #2- On December 30, 2024, there was new graffiti in the same area. Notice that the graffiti reported on 11/26/24 was still there in addition to profanity on the side of the bench. Should kids be exposed to this type of language in public parks where they go play and learn from what they see in their soundings?

Picture #3- 01/25/25, we visited this area and we were in disbelief when we noticed that graffiti from December was covered but not the graffiti which was there since 11/26/24. How is that possible? How could someone miss that?

It would take under 10 seconds to cover this graffiti but it seems absurd that NOT the painter nor his supervisor have any respect for the kids and the public who wish to have these areas clean for the children. Painted claimed in previous occasion that he had more work to do but not enough time. Yet, he stood around doing nothing for about 30 minutes.

We have reported that.

City officials we would appreciate some accountability in regards to these public employees. We request for graffiti to be completely covered when reported.

We appreciate your support in this important matter.

If the CIS or resolution pertains to a matter *listed on the Commission's agenda*, during the time the matter is heard, the designated Neighborhood Council representative should be given an opportunity to present the Neighborhood Council's formal position. We encourage becoming familiar with the City Councils rules on the subject. At the Chair's discretion, the Neighborhood Council representative may be asked to have a seat at the table (or equivalent for a virtual meeting) typically reserved for City staff and may provide the Neighborhood Council representative more time than allotted to members of the general public. They are also permitted up to five (5) minutes of time to address the legislative body. If the CIS or resolution pertains to a matter *not listed on the agenda*, the designated Neighborhood Council representative may speak during General Public Comments.

#### VENICE NEIGHBORHOOD COUNCIL PARK MAINTENANCE ISSUES

#### Penmar Recreation Center

- 1. Graffiti removal. There is a lot of graffiti in and around the park that only gets removed if somebody calls in to 311. Penmar park staff should be calling 311 on a daily basis.
- 2. Removal of trash.
- 3. Cleaning of bleachers. There are at least 4 bleacher areas that are infrequently cleaned. Cleaning schedule should be at least twice a week, for removal of leaves, mud and trash and food waste left on the bleachers.
- 4. Removal of rat infested shrubs around the tennis courts.
- 5. Trim low trees at the corner of Penmar Ave. and Rose Ave. for increased visibility on the corner.

#### Penmar Golf Course

1. Replace broken fence along Rose Ave., from the golf course parking lot going west to Frederick St.

#### Oakwood Park

- 1. Re-open previously available exterior-access public bathrooms.

After working closely with the Council Office, we have specified that smoking is permitted only on the course tee boxes and fairways of the golf course. To ensure proper disposal, we have provided cigarette receptacles on the tee boxes and have extensive signage in our parking lots prohibiting smoking in non-designated areas. The proposed ordinance not only builds on the successful precedent set during the 1984 Olympic Games but also ensures compliance with California's CEQA statutory exemptions for Olympic-related projects. The NWWNC urges the City Council to adopt this motion to ensure that Los Angeles is fully prepared to deliver a world-class event that leaves a lasting legacy for our community.

As community stewards for Griffith Park, in the wake of our region's recent destructive wildfires, we are heartened to see policy-makers taking a thoughtful approach to fire safety. We write in strong support of CF# 25-0006-S35, which seeks to clarify and improve the City of Los Angeles' response to Red Flag Alerts/Warnings and declarations of a Particularly Dangerous Situation (PDS) by the National Weather Service.

Given the likelihood of future fire emergencies, it is essential that City departments be given both the tools and the resources to carry out prevention and response activities in the most effective manner. Doing so will protect residents, visitors and City assets. Here in Griffith Park, we were fortunate that the January 20, 2025 fire was observed quickly, that first responders were able to reach the scene rapidly, and that wind conditions did not lead to an out-of-control blaze that could have threatened the park and nearby neighborhoods.

As this policy-making process moves forward, we will weigh in with additional comments and questions. In the meantime, we appreciate the thoughtful manner in which the City Council is seeking to address the need for clear protocols, policies and procedures to guide City agencies' actions during times of extreme weather events.

Hon. Councilmembers,

As community stewards of Griffith Park, Los Angeles' largest park and great urban wilderness, the Griffith Park Advisory Board (GPAB) appreciates the intent behind Motion 25-0006-S30 and the commitment to ensuring public safety. However, Griffith Park is unique among city parks, and we cannot support a blanket closure on Red Flag days without a more comprehensive evaluation of its impacts.

Closing Griffith Park, even for the modest number of Red Flag days in a typical year, carries significant consequences. It requires substantial staffing for enforcement, results in lost revenue for the Department of Recreation and Parks as well as park concessionaires, disrupts the livelihood of part-time employees, and limits access for bike commuters and other stakeholders who rely on the park. Additionally, a full closure may inadvertently push visitors into less monitored and potentially more hazardous areas.

Calling for an all-encompassing closure at this time we feel is entirely premature, we urge the City Council to do further due diligence before prescribing any drastic measures. We welcome the opportunity to collaborate on solutions that balance safety with the needs of the many Angelenos who depend on Griffith Park when ultimately arriving at a pragmatic way forward.

Thank you for your consideration. We look forward to further discussions on this important issue.

there is a sign posted at the lake that says " no fishing within 100 ft of the dock" with no penal code. There is also another sign with all the park lakes and rules posted 20 feet away with the same "no fishing within 100 ft of the dock"

all the rules ( its about 10 or 15 ) have penal codes next to them EXCEPT the one stating "no fishing within 100ft of the dock"

Because I do not see a penal code and I want to fish near the dock ( as the fish im after love the shade it provides ) I fish it and continued to be harassed by the life guards that patrol in the truck that is parked right next to the dock.

There have been a few instances where they escalate there voice after I have ( gone up to them to inform them of my intent with an explanation ) and then went on my way to the dock.

They have called the rangers down, and spoken with me, and I inform them of the same thing... there is no penal code, and I want to fish there. I even suggested to them im willing to take a ticket or get arrested if it actually is enforceable.

they did not arrest me or give me a ticket, even when I suggested that he should if it was enforceable.

I believe im within my right to fish the lake as close to the dock as I choose.
