The Cabrillo Beach Bathhouse was built in 1932 as a destination for Los Angeles residents riding the Pacific Red Car. They could rent a bathing suit for 10¢ and enjoy a day at the beach. The Bathhouse was also used for the 1932 Summer Olympics and during the 1930's and 40's became the 1st home of the Cabrillo Beach Museum. After being refurbished the Bathhouse was declared a historic landmark and dedicated in October of 2002 to the people of Los Angeles. It is now part of the City of Los Angeles, Department of Recreation and Parks . Our venue is also a popular Filming location for Hollywood and has been used in countless Movies , Commercials and TV Shows.

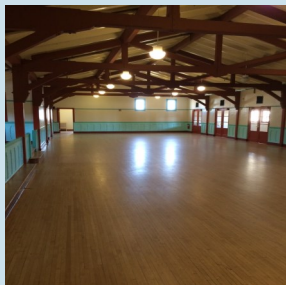

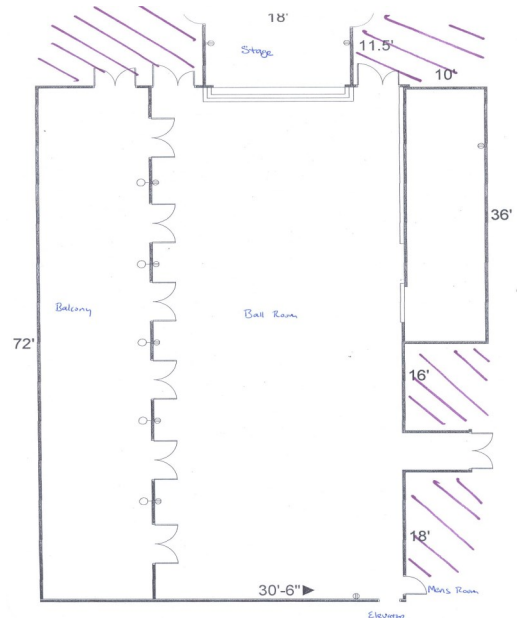

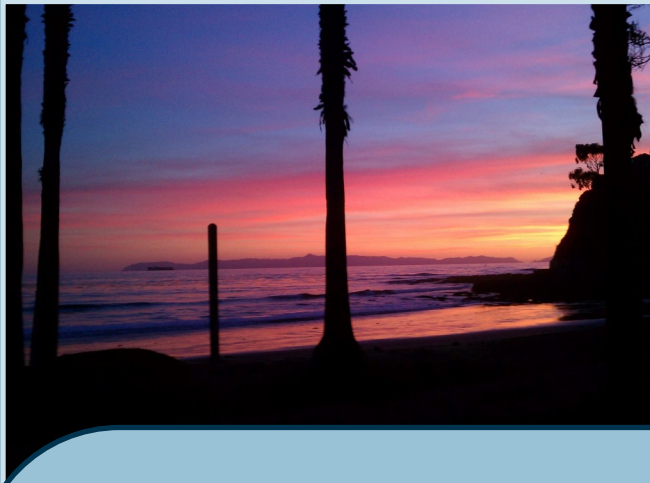


Ballroom Floor Plan
