Requirements

Parent/Guardian must be at least 18 years old. For the Father/Son weekend we consider a 'father' as any significant male adult figure in a young boys life: dads, male guardians, brother, uncle,, grandfather, etc. We consider a 'son' as any significant young boy in a man's life: son, brother, nephew, cousin, grandson, etc.

Registration Procedure

Complete the online registration process by submitting the online payment at least two weeks prior to the start of the program. If you register after the deadline, a \$20.00 late fee will automatically be added to your registration fee. It is understood and agree that no refund or reduction in fees are made for late arrival, early departures, withdrawals or requests to leave due to misconduct. Onces the sessions fill-up, a waiting list will be started online. Names will be added in the order in which applications are received.

***For a smoother registration process, check that all participants being registered are

listed in your household before beginning the registration process.

Registration will be accepted on a first-come, first-served basis. The rules of acceptance and participation in the program are the same for all, without regard to race, color, religion or national origin. Persons with disabilities are welcome to participate in our programs. Reasonable accommodations will be made with prior arrangement. Please allow two weeks minimum notice for interpretive services.

Cancellation and Refund Policy

All cancellations must be in writing. In order to request a refund, please submit the request for refund form. The form is available at www.laparks.org/camp/griffith-park-boys-camp Refunds take 6-8 weeks, after the request is received. Registration fee will be refunded as follows: less \$20.00 per person with two weeks or more notice; less \$40.00 per person with less than two weeks notice. Cancellation deadline is 12:00 p.m. on the Thursday prior to the weekend registered for. There will be no refunds for FAILURE TO SHOW.

Supervision

Children must be accompanied and supervised at all times by their parent/guardian. Griffith Park Boys Camp Staff is responsible for preparing and leading activities; they will not be available to supervise children. Unaccompanied children will be returned to their parent/guardian immediately. Proper authorities will be contacted if the adult refuses to accompany their child(ren).
