Requirements

Parent/Guardian must be at least 18 years old. For the Father/Son weekend we consider a 'father' as any significant male adult figure in a young boys life: dads, male guardians, brother, uncle,, grandfather, etc. We consider a 'son' as any significant young boy in a man's life: son, brother, nephew, cousin, grandson, etc.

Registration Procedure

Complete the online registration process by submitting the online payment at least two weeks prior to the start of the program. If you register after the deadline, a \$20.00 late fee will automatically be added to your registration fee. It is understood and agree that no refund or reduction in fees are made for late arrival, early departures, withdrawals or requests to leave due to misconduct. Once the sessions fill-up, a waiting list will be started online. Names will be added in the order in which applications are received.

***For a smoother registration process, check that all participants being registered are listed in your household before beginning the registration process.

Registration will be accepted on a first-come, first-served basis. The rules of acceptance and participation in the program are the same for all, without regard to race, color, religion or national origin. Persons with disabilities are welcome to participate in our programs. Reasonable accommodations will be made with prior arrangement. Please allow two weeks minimum notice for interpretive services.

Cancellation and Refund Policy

All cancellations must be in writing. In order to request a refund, please submit the request for refund form. The form is available at www.laparks.org/camp/griffith-park-boys-camp

Refunds take 6-8 weeks, after the request is received. Registration fee will be refunded as follows: less \$20.00 per person with two weeks or more notice; less \$40.00 per person with less than two weeks notice. Cancellation deadline is 12:00 p.m. on the Thursday prior to the weekend registered for. There will be no refunds for FAILURE TO SHOW.

Supervision

Children must be accompanied and supervised at all times by their parent/guardian. Griffith Park Boys Camp Staff is responsible for preparing and leading activities; they will not be available to supervise children. Unaccompanied children will be returned to their parent/guardian immediately. Proper authorities will be contacted if the adult refuses to accompany their child(ren).

I am aware that there are certain risks of injury and/or damage inherent in the program's activities;

I understand that if I and/or my child(ren) misbehaves and/or is sick and needs to be sent home; I agree to pick them up or take them home at the time requested by the Camp staff;

I understand that under certain medical conditions the Camp staff may require a written authorization based on a physical examination by a licensed medical person as requirement for myself and/or the Minor(s) to participate in the program;

I confirm to the best of my knowledge and belief that I and/or the Minor(s) is not subject to a physical or mental infirmity nor under the influence of any medication or substances which might hinder their safe participation or the safety of others in the program;

I will follow and/or instruct the Minor(s) to abide by all safety rules, policies and regulations and to take reasonable precautions to minimize risks of injury or damage arising from participation in the Program;

I give my consent for myself and the Minor(s) participate in all aspects of the program;

I knowingly assume full responsibility for all risks of bodily injury, emotional injury, death or property damage that may occur in relation to myself and/or the minor(s) as a consequence of participation in the Program at the Camp;

I agree and/or give my consent for myself and/or the minor(s) to be transported by: car, van, chartered bus, chartered school bus and/or public transportation as part of the program;

I understand that the Camp has no obligation to obtain medical treatment for myself and/or the Minor(s). Should it become necessary for me and/or the Minor(s) to have emergency medical care while participating in the program;

I give the Camp personnel my permission to use their judgment in obtaining medical care, and; I give permission to the medical care provider selected by the Camp personnel to render medical care deemed necessary and appropriate;

I understand that the Camp at it's sole option but without obligation may procure insurance to cover part or all of such medical expense incurred by myself and/or the Minor(s);

I understand and agree that any cost incurred for such treatment which is not covered by insurance shall be my sole responsibility;

I (print name) _____ waive all rights of recovery which the Minor(s) and/or I have now or in the future, whether known or unknown, against the City of Los Angeles, Department of Recreation and Parks, Griffith Park Boys Camp, its officers, agents, employees and/or personnel, and I release, acquit and forever discharge the City of Los Angeles, Department of Recreation and Parks, Griffith Park Boys Camp, its officers, agents, employees and/or personnel, from any and all liability for any bodily injury, emotional injury, or other personal injury, damage, loss or expense, claims, demands, causes of action, costs, loss of services or use, compensations, debts, monetary damages, including but not limited to attorney fees, which result from or are in any way connected with myself and/or the Minor(s) participation in the Program or any related activities;

I agree to keep the Camp advised if I will be out of contact for any period of time during the Program and to provide additional and/or alternate contact information prior to my leaving;

I also authorize the Camp, City of Los Angeles and Department of Recreation and Parks to make, procure and/or use photographs, films, tapes, digital media recordings or other likeness of myself and/or the minor(s) physical image and/or voice as for use with the program and/or camps' publicity, marketing and/or advertising materials;

I have read this agreement and I understand what it means to my legal rights and my and/or the Minor's participation and my signature is made of my own free will and act;

I agree to abide by the rules and policies set forth in this registration and waiver release form;

I have read and understand the payment, refund and conditions of enrollment policies as found in this registration form;
