THE FOLLOWING RULES ARE MEANT TO BE DISCUSSED AND UNDERSTOOD BY BOTH PARENTS AND PARTICIPANTS.

- PARTICIPANTS ARE EXPECTED TO PARTICIPATE IN ALL ACTIVITIES AND FOLLOW DIRECTIONS AT ALL TIMES
- SAFETY RATIOS OF I STAFF PER 10 CHILDREN.
- SANDALS OR OPEN TOE SHOES SHOULD NOT BE WORN TO PROGRAM.
- ALL PARTICIPANTS MUST SHOW RESPECT FOR THEMSELVES, OTHER PARTICIPANTS AND THE PROGRAM STAFF.
- PARTICIPANTS MUST TAKE A BUDDY WITH THEM AND NOTIFY STAFF WHEN THEY GO TO THE RESTROOM AND/OR TO **GET A DRINK OF WATER.**
